I understand that I shall not be approved for service if I am named as a perpetrator of a founded report of child abuse within the past five (5) years or have been convicted of any of the crimes listed above or of offenses similar in nature to those crimes under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico, or a foreign nation, or under a former law of this Commonwealth.

I understand that if I am arrested for or convicted of an offense that would constitute grounds for denying participation in a program, activity or service under the Child Protective Services Law as listed above, or am named as perpetrator in a founded or indicated report, I must provide the Board of Directors of the Prospect Park Fire Company No. 1 with written notice no later than 72 hours after the arrest, conviction, or notification that I have been listed as a perpetrator in the Statewide database.

I understand that if the Board of Directors of the Prospect Park Fire Company No. 1 have a reasonable belief that I was arrested or convicted for an offense that would constitute grounds for denying participation in a program, activity or service under the Child Protective Services Law, or was named as perpetrator in a founded or indicated report, or I have provided notice as required under this section, the Board of Directors shall immediately require me to submit current clearances obtained through the Department of Human Services, the Pennsylvania State Police, and the Federal Bureau of Investigation, as appropriate.

I understand that if I willfully fail to disclose information required above, I commit a misdemeanor of the third degree and shall be subject to discipline up to and including denial of a volunteer position or revoking of membership.

I understand that the Prospect Park Fire Company No. is required to maintain a copy of my clearances and that they must be renewed every 36 months.

I have ____ (have not ____) resided in the Commonwealth of Pennsylvania continuously for the previous ten years. I understand that I will be required to obtain a clearance through the Federal Bureau of Investigation if I have resided outside of Pennsylvania within the past ten years.
